Your cost for IFS Guidance is **\$150 per hour** and is due at the time of service (Initial session is **\$200**). In-between session calls are billed in 15-minute increments at **\$40**. 90-minute sessions are billed at **\$225**.

Andrea Feucht offers a limited number of sessions each week. Missed sessions and short-notice cancellations prevent her from helping others in need. **Missed sessions and nonemergency cancellations within 48-hours of your appointment time are billed at the full price.**

In such cases, you will receive a text from the Center for Embodied Spirituality's owner, Sabrina Santa Clara, through IvyPay, inviting you to pay for the session with a credit card, which will be saved in IvyPay's secure data system. You will receive a text message whenever your card is charged. International clients who do not have US phone numbers may pay for such sessions via Paypal (info@SabrinaSantaClara.com) 48 hours prior to their scheduled session time.
